6. Purchase of Replacement Display Boards

The Town Clerk circulated a variety of designs, quotes and options for the replacement of the display boards.

These boards were to be replaced due to health and safety issues with the existing boards.

It was agreed that the Town Council would purchase the following:

- i) 3 x 7 panel concertina boards on castors
- ii) 2 x 5 panel concertina boards on castors

The costs from the three suppliers were very close at £1,804.00 - £2,149.00 and the Town Clerk was asked to contact each supplier to see if there was any bulk discount or free delivery.

RESOLVED that the purchase of replacement display boards be approved and that the Town Clerk was delegated authority to place the order with the company who provided the best price.
