### 123. Minutes – Property Management Committee

RESOLVED that the minutes of a meeting of the Property Management Committee held on Thursday 2<sup>nd</sup> December 2021 (Minute Numbers 21-26; Pages 10-11) be received and the contents contained therein be approved.

#### 124. Town Hall Refurbishment – Update on progress so far

A written report was circulated which set out the progress to date with the Town Hall refurbishment project.

The main aim of the project was to improve accessibility to the building by providing ramped access, automatic doors, accessible toilets on the ground and first floor and a lift providing access to each floor.

The secondary aim of the project was to improve efficiency of the heating system and remove the reliance on gas powered heating. This would be achieved by replacing windows and installing a new heating and cooling system.

Finally, a number of new community rooms would be created, and the Council intended to provide free access to the public and local organisations.

The initial draft budget of £463,021.44 was set out. Funding from various sources totalling £468,720.00 was set out.

RESOLVED that the report be received and the initial draft budget of £463,021.44 was approved.

## 125. Town Hall Refurbishment – Appointment of Contractor

RESOLVED that the contract for the refurbishment of Normanton Town Hall be awarded to Dhand Construction at a contract value of £373,821.44. (subject to receipt of Landlords Consent from WMDC)

# 126. Town Hall Refurbishment – Appointment of Decorator

RESOLVED that the contract for decorating be awarded to 5 Towns Decorating at a contract value of £18,527.69 (plus cost of wallpaper). (subject to receipt of Landlords Consent from WMDC)
